**MOBILISATION OF CONSTRUCTION WORKERS**

**5 SQUARES - 5 SUBURBS**

***There is a need for*** stable and lasting ***industrial policies for the*** construction sector to defend existing jobs and to create new ones.

***Industrial policies are needed*** to redevelop and regenerate the built environment, to achieve the goals of energy efficiency, earthquake safety and environmental sustainability set by the UN and Europe.

***We need resources and tools*** to realise the 15-minute city, to ensure quality homes, green areas, and neighbourhood services starting in our suburbs.

***We need quality,*** advanced ***infrastructure and public works*** that from major interventions to the widespread redevelopment of schools, hospitals and social housing will ensure a better life for all.

That is why we ask:

- ***the amendment of decree 11/2023 on building bonuses***, which risks destroying 100,000 jobs and, above all, excluding millions of low-income citizens from the possibility of having a more liveable and safe, more energy-efficient, healthier home with cheaper bills. We must urgently guarantee the release of credits, but above all give stability to the incentive percentages for the next 10 years, guaranteeing the transfer of credit and the discount on the invoice for the inexperienced (with 100 per cent of the costs also through recoveries on the bill) and for low and medium incomes (less than 30 thousand euro), for condominiums and for those living in the suburbs. Providing direct public intervention, even extraordinary, for Public Residential Housing;
- ***a framework law for urban regeneration***, with new urban planning based on increased resources and participatory tools, consistent with the objectives of the Next Generation Eu and the UN Agenda for Sustainable Cities;
- ***stringent constraints on the obligation to apply and respect the CCNL Construction*** Contracts in all works contracts within the perimeters and fields of application

of Annex X of Legislative Decree 81/2008, starting with public works contracts, **improving the provisions of the new Procurement Code** against all forms of contractual dumping, irregular work and criminal infiltration;

- **the reintroduction of the ban on cascade subcontracting** as provided for in the current Procurement Code and the valorisation of more structured companies, their qualification, and their growth in size.

We want industrial policies, certainty of resources, more planning for **higher quality work**, company qualification, new materials and new construction techniques.

We want to **become a better**, more efficient, safe and environmentally sustainable **country**.

To do this, we must defend and **value quality, safe and legal work, which is indispensable to eliminate deaths at work and especially on construction sites**.

On this as a trade union we are ready to make our contribution, but we note that the government has not involved the trade unions in any table on procurement and sectoral policies, not recognising the workers the role they deserve: **that of protagonists in the economic and social life of the country**.
